Newsletter to existing councils and new councils - April 2024

Judging by the many posts on social media, newspaper articles and the 5,000 signatures to a petition against Farnborough Airport's proposed expansion, what happens at the airport and the changes to flightpaths is a big issue for many people in west Surrey and east Hampshire. Since the airport was sold to private investors in 2000, the number of flights has increased to 33,000 a year (with a permit for 50,000). In February Farnborough Airport Ltd submitted a planning application for an increase to 70,000 flights (doubling the number at weekends) and operating larger aircraft. While the airport has a licence for "business" flights, most of the increase has been at weekends and leisure flights for the very wealthy. With there being on average only 2.5 passengers per plane and 40% flying empty, you can see why people are unhappy about the increase in noise but also they are concerned about emissions impacting climate change and the health risk of ultrafine particle pollution. Noise is not adequately measured. Emissions and ultrafine particle pollution aren't measured at all.

Many local residents individually or in small groups have raised concerns. In 2020, Farnborough Noise Group was established to try and speak with one voice and to evaluate the technical information being sent out by the airport, the Civil Aviation Authority and the Department for Transport. While there is an airport committee (the Farnborough Aerodrome Consultative Committee - FACC) that should be holding the airport to account, what we have seen is that the committee is ineffective because it is paid for and controlled by the airport. Over the past four years there have been many challenges and questions to the airport and the FACC. In response, the public (and FNG) have been progressively excluded from FACC meetings and questions that have been raised have been ignored.

Farnborough Noise Group has provided regular updates and impartial fact-based information to the public and to 65 parish, borough and county councils who asked to be kept informed. The group has a website (www.farnboroughnoise.org) and a Facebook page (www.facebook.com/groups/farnboroughnoise). Of the 65 councils that receive newsletters, 31 responded to Rushmoor Borough Council's consultation on the airport's expansion application. The council contacted a further 57 councils and 10 responded. The number of responses to the application is surprisingly low, given the impact it will have on hundreds of thousands of people in these constituencies. 2,200 members of the public took the time to submit a written objection to the application. With local elections (and a general election) coming up, the airport has become an election issue. There have been large demonstrations at the airport (supported by Greta Thunberg and Chris Packham) and the situation has been reported in the national and international press.

Insufficient information was submitted by the airport in the planning application so the decision on it has been delayed by Rushmoor Borough Council until after the May elections. And this takes us to the reason for contacting you.

The airport claims that it generates revenue and jobs for the Rushmoor area (we dispute the business case provided by the airport as it excludes things like reduction in property prices). The issue is that the harm caused extends much further than Rushmoor. For example, noise disturbance of the new concentrated flightpaths impacts people many miles away. Some of these areas are places like the National Park. Much of the additional information requested by the airport only relates to Rushmoor and very little information has been requested that addresses the concerns of the public in other boroughs.
